WHAT WE COLLECT

If you send an inquiry through the contact form, we collect:

- the reason for contact (capital, deal flow, or partnership)
- name
- email address
- company or fund name
- your message

You may also email us directly at contact@melitho.vc. We then process whatever you choose to send.

If you browse the site, our host and, if you accept analytics, our analytics provider receive standard technical information: page URL, referring URL, browser and device type, and a coarse location derived from IP. Vercel Web Analytics does not set cookies. Visitors are identified by a hash of the incoming request that expires after 24 hours and is not used to track you across sites or days.

We do not ask for identity documents, payment details, or account credentials on this site.

We do not sell personal information. We do not use the contact form for a marketing list.

WHO WE SHARE IT WITH

We use service providers to run the site:

- Vercel Inc. — hosting, the contact-form server action, and Web Analytics
- the email systems we use to receive and reply to inquiries

They process information on our instructions. We may also disclose information if required by law, or to protect our rights or the safety of others.

The site is hosted on Vercel's network, which may process data in the United States and other countries.

HOW LONG WE KEEP IT

Inquiry emails and form submissions are kept for as long as needed to handle the request and keep ordinary business records, then deleted or archived.

Analytics data is aggregated. Vercel's visitor hash is discarded after 24 hours.
